

# STATING OF STATE OF S

#### How much does a Parish Church like this cost?

- Last year our basic costs were £44,015 or £846 per week (not including repairs and work on the building).
- The donations we received from the congregation amounted to £10,998 or £221 per week
   (including reclaimed gift aid). This is generous giving for a congregation such as ours, but still only
   covers about a quarter of our costs. The rest of our income is derived from hall rentals, mostly from
   the Romanian Orthodox Church, and this will be less than in the past as it is now a fixed rent.
- Our costs in 2024 are going to be substantially higher, as our gas bill has gone up by 300%, and our electricity cost will double.
- At the same time, the donation we are able to make to the Diocesan Common Fund, which pays for stipends, housing, training and Diocesan support, is less than half of the cost to the Diocese of maintaining a parish church here – even though the priest in this parish is non-stipendiary. This means that we are effectively being subsidised by wealthier churches and central Diocesan funds.

These charts show our total costs in 2022, and the Diocesan Common Fund for 2024:



#### Our Treasurer writes:

"The money that you give regularly each week or month has dropped by 20%, and donations put in the collection tray are down by 38%. We now receive an average of £172 per week. We are still surviving on the rent from the Romanian church, but this is now a fixed rent and is less than it used to be. There are many improvements to the church building that we will need to pay for.

"We are very grateful for your continued support at a time when everyone's incomes are stretched, but the church finances are stretched too, and we would ask you to please consider if you could increase your giving, even by just a small amount, and **especially if you could pay by standing order** through the bank, as this does not incur bank charges. *Our charges are particularly high when paying in cash or cheques.*"

The Church of England recommends that committed church members give 5% of their disposable income to their church, and 5% to other charities. In the light of this we are asking all members of St Matthias to consider what they are able to commit to giving in 2024. If you feel you are able to increase your regular giving, or to make a new pledge, please complete the form overleaf and return it in the collection plate during Advent. Thank you!

- 1. As your Gift Aid declaration covers donations that you will make in the future, please notify the PCC Treasurer, c/o The Vicarage, 48 Rushgrove Avenue, Colindale, NW9 6QY, if you change your name or address while the declaration is still in force.
- 2. You can cancel the declaration at any time by notifying us. It will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
- **3**. You must pay an amount of income tax and/or capital gains tax at least equal to the tax that we reclaim on your donations in the tax year (currently 25p for every £1 you give).
- **4.** If in the future, your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that we reclaim, you can cancel your declaration as described on note 2 or notify the PCC Treasurer, St Matthias Colindale.
- 5. If you pay tax at the higher rate, you can claim further tax relief in your Self-Assessment tax return.
